ARTICLES OF INCORPORATION

Executed by the undersigned for the purpose of forming a South Dakota Corporation under SDCL 47-22 South Dakota Nonprofit Corporation Act.

ARTICLE I NAME

The name of the corporation is: WALTON-SCHULER DITCH COMPANY.

ARTICLE II EXISTENCE

The period of existence is PERPETUAL.

ARTICLE III PURPOSES

The purposes for which the corporation is organized:

To own, maintain, construct, purchase and operate canals, ditches, reservoirs, dams, laterals, flumes and waterways for storage, irrigation, milling, domestic and other purposes; also to use, lease, donate or convey any of the below-named property or privileges to other individuals or entities;

To possess by purchase, lease, donation or otherwise, property, whether real or personal;

To acquire and become owner of the right to appropriate or take from Spearfish Creek or any other river or stream in Lawrence County, South Dakota, a sufficient supply of water to fill and supply the canal or ditch known as the Walton-Schuler Ditch, and through and from said canal to convey and distribute such water to the lands of the members of the corporation for domestic, irrigation and other beneficial uses;

To acquire by purchase or otherwise water rights and priorities to the use of water from Spearfish Creek and other streams, and the ditches or other waterways through which the waterway may be supplied for beneficial purposes, and to apply the said water rights and priorities to beneficial purposes through the canal above-mentioned, or any other canal owned, purchased, or constructed by the corporation, of, through or in which it has

acquired or may acquire the right to apply such water rights or priorities, also including the right to procure and own by purchase or otherwise such water rights as it may desire for beneficial purposes, and also to procure any interest in any reservoirs, ditches or water rights however the same may be represented, and all other property used in connection therewith and necessary therefore, using the same for beneficial purposes, together also with the right to change the point of diversion and use of any and all water and water rights owned or so acquired to any point or place on the course of said Spearfish Creek or any other stream used by it, and to sell or otherwise dispose of any part or all of the ditches, reservoirs, water rights or other property of the corporation.

ARTICLE IV MEMBERSHIP

The corporation is to have one class of voting members of the corporation. Members of the corporation shall be the owners of land who are eligible to receive water from the Walton-Schuler Ditch as provided in the Bylaws of the Corporation.

ARTICLE V VOTING RIGHTS

Voting rights of the members shall be provided for in the Bylaws.

ARTICLE VI BOARD OF DIRECTORS

The board of directors shall consist of five (5) members. The directors shall be elected by a majority vote of the members.

ARTICLE VII REGISTERED OFFICE AND REGISTERED AGENT

The street address of its initial registered office is 282 Upper Valley Road, Spearfish, South Dakota 57783, and the name of its initial registered agent at such address is Douglas "Woody" Hayes.

ARTICLE VIII INITIAL BOARD OF DIRECTORS

The number of the initial board of directors shall be five (5). The names and addresses of the initial board of directors are:

The initial board of directors shall serve until their successors are elected and qualified at the first annual meeting of members.

ARTICLE IX INDEMNIFICATION

The corporation shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, other than an action by or in the right of the corporation, by reason of the fact that that person is or was a director, officer, employee or agent of the corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, limited liability company, partnership, joint venture, trust or other enterprise, against expenses, including attorneys' fee, judgments, fines and amounts paid in settlement actually and

reasonably incurred by that person in connection with such action, suit or proceeding if that person acted in good faith and in a manner that person reasonably believed to be in or not opposed to the best interests of the corporation, and, with respect to any criminal action or proceeding, had no reasonable cause to believe such conduct was unlawful. The termination of any action, suit or proceeding by judgment, order, settlement, conviction, or upon a plea of nolo contendere or its equivalent, does not, of itself, create a presumption that the person did not act in good faith and in a manner which that person reasonably believed to be in or not opposed to the best interests of the corporation, and, with respect to any criminal action or proceeding, had reasonable cause to believe that such conduct was unlawful.
